GENERAL ORDER IMPLEMENTING MARCH
30, 2020 EMERGENCY RELIEF

GENERAL ORDER
2020-006

Based on Executive Order N-38-20, dated March 27, 2020, issued by Governor Gavin Newsom, and the authority granted to the Court in the March 30, 2020 statewide order of Chief Justice Tani G. Cantil-Sakauye, Chair of the Judicial Council of California,

This Court issues General Order 2020-006, as follows:

1. The deadlines for the following court proceedings are extended as noted and on a temporary basis. At such time as the Chief Justice amends, rescinds or modifies her March 30, 2020, statewide order to address changing circumstances, the Court will likewise amend, rescind or modify this implementation order accordingly.

1 2. These extensions of time are in addition to any relief provided pursuant to
2 the Court's specific emergency orders issued on March 18, 2020, and addressed in General Order
3 2020-004 Implementing Emergency Relief. To the extent that this General Order 2020-006
4 conflicts with General Order 2020-004, or any other General Order, this General Order 2020-006
5 controls.

7 3. The Court extends the time periods provided in sections 583.310 and
8 583.320 of the Code of Civil Procedure to bring an action to trial by sixty (60) days from the last
9 date on which the statutory deadline would otherwise have expired. The Court extends the time
10 period provided in section 859b of the Penal Code for the holding of a preliminary examination
11 and the defendant's right to release from ten (10) court days to not more than thirty (30) court
12 days.

14 4. The Court extends the time period provided in section 1382 of the Penal
15 Code within which a trial must be held by no more than sixty (60) days from the last date on
16 which the statutory deadline otherwise would have expired.

18 5. The Court extends the time period provided in section 825 of the Penal
19 Code within which a defendant charged with a felony offense must be taken before a magistrate
20 from 48 hours to not more than seven (7) days.

1 6. The Court will calculate the sixty (60) day continuance of jury trials
2 authorized in the Chief Justice's March 23, 2020 emergency order from the date for which the
3 trial was set or extended (whichever is longer) as provided in No. 2 or No. 4 above.
