REQUEST FOR COURT TRIAL - ADVISEMENT OF RIGHTS AND PLEA OF NOT GUILTY IN WRITING (Vehicle Code section 40519)	

I understand that I have the following rights:

TO THE ASSISTANCE OF AN ATTORNEY AT MY OWN EXPENSE. (The court won't appoint the public defender in infraction cases punishable only by fine).

TO A SPEEDY AND PUBLIC TRIAL BEFORE A JUDGE. To present evidence and call witnesses at the trial. In that regard, to have the clerk issue a subpoena without charge to compel witnesses to attend the trial and for the production of documents helpful to my defense.

TO CONFRONT AND CROSS-EXAMINE MY ACCUSERS. This is, to see, hear and question the witnesses against me at the time of trial.

TO PRESENT EVIDENCE TO SHOW THAT I AM NOT GUILTY OF THE OFFENSE.

TO REMAIN SILENT AND NOT INCRIMINATE MYSELF. I understand that I do not have to testify at the trial unless I choose to do so.

I HAVE READ AND UNDERSTAND THE ABOVE RIGHTS. I HEREBY PLEAD NOT GUILTY TO THE CHARGES LISTED BELOW, AND REQUEST A TRAFFIC COURT TRIAL.

I UNDERSTAND BY USING THE PROCEDURE SET FORTH ABOVE, I HAVE GIVEN A WRITTEN PROMISE TO APPEAR AT THE TIME DESIGNATED BY THE COURT FOR TRIAL, AND FAILURE TO APPEAR AT THE TRIAL MAY RESULT IN THE JUDICIAL OFFICER HEARING THE CASE IN MY ABSENCE, OR CONSIDERING MY FAILURE TO APPEAR AS AN ELECTION TO PROCEED WITH A TRIAL BY DECLARATION (VC 40903).

I UNDERSTAND BY ENTERING A WRITTEN PLEA OF NOT GUILTY, I WAIVE MY RIGHT TO BE TRIED WITHIN THE STATUTORY PERIOD (45 days).
