## **Stanislaus County Interim Supplemental Bail Schedule**

1. Pursuant to Penal Code Section 1269b, and Circulating Order Number: CO-20-11 issued by the Judicial Council of California (Judicial Council), the Superior Court of Stanislaus County (Superior Court) adopts this Interim Supplemental Bail Schedule to address the impact of the COVID-19 pandemic.
2. The Interim Supplemental Bail Schedule repeals the Emergency Bail Schedule, effective February 19, 2021.
3. The Interim Supplemental Bail Schedule is effective January 1, 2022, and will remain in effect until repealed or amended by the Superior Court. It is subject to revision based upon public safety risk in the general community and custodial facilities presented by COVID-19.
4. Nothing in the Interim Supplemental Bail Schedule restricts the ability of the court to deny bail as authorized by article I, section 12, or 28(f)(3) of the California Constitution or to modify bail pursuant to Penal Code Section 1269c.
5. The Interim Supplemental Bail Schedule does not require bail to be reset for any person for whom bail was previously set in accordance with the COVID-19 Emergency Bail Schedule (Emergency Rule 4), or the Emergency Bail Schedule, effective February 19, 2021.
6. The Interim Supplemental Bail Schedule does not apply in any of the following circumstances:
  - 6.1. The person arrested is subject to an outstanding bench warrant issued by ~~the~~ a Court for the person's failure to appear;
  - 6.2. The person is arrested on multiple charges and at least one charge is listed in subsection 7.1-7.54 below;
  - 6.3. The person is arrested or booked on a violation of felony probation, PRCS, mandatory supervision, and/or parole.
7. The current countywide bail schedule effective February 16, 2021, remains in effect for all offenses listed below, including any count-specific conduct enhancements and any status enhancements, or if the person arrested is subject to a condition set forth in paragraph 6.1-6.3, above.
  - 7.1. A serious felony, as defined in Penal Code section 1192.7(c), or a violent felony, as defined in Penal Code section 667.5(c)
  - 7.2. Any felony offense allegedly committed while the accused is released from custody on bail, including \$0.00 bail, set pursuant to the current countywide bail schedule effective February 16, 2021, the Emergency Bail Schedule (Emergency Rule 4), or the Emergency Bail Schedule, effective February 19, 2021.
  - 7.3. Any charges with the enhancements/allegations of Penal Code §§ 12022.5 (personal use of a firearm in commission of felony); 12022.7 (infliction of great bodily injury); 667(d) ("strike" priors) could be alleged.

8. Bail for all other felony offenses will be set at \$1,000. Bail for all other misdemeanor offenses will be set at \$100.
