The list of committee members has been updated on the page and the prior bond committee information has been included under Measures Q & R.

Minutes:

- a) The Respondent agrees with the finding.
- b) The District was unaware that minutes needed to be posted since the approved minutes are on our board agendas. The approved board minutes have been uploaded for Measures B, Q, and R. The District will continue to post approved minutes for Measure B as they become available.

Annual CBOC Reports:

- a) The Respondent does not fully agree with the finding.
- b) The District switched websites 4 years ago and upon switching, it was missed that the Annual CBOC Report was not carried over for Measures Q & R. The annual report has now been posted. For Measure B, the Annual CBOC Report was approved on May 4, 2026 and then presented at the District's regular board meeting on June 9, 2026. The annual report was posted to the District's website on June 11, 2026. When the Grand Jury looked at Hughson's website, the Annual CBOC Report had not been approved yet.

Financial and Performance Audits:

- a) The Respondent does not fully agree.
- b) The annual audit reports were available on the District's website for Measures Q and R. For Measure B, the Annual audit was approved on May 4th, 2026 and presented at Hughson's regular board meeting on June 9th, 2026 and posted to the website on June 11, 2026. When the Grand Jury looked at Hughson's website, the audit was not approved yet.

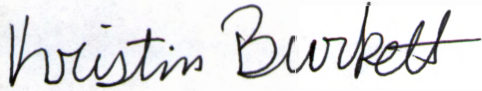
Number of Members in Qualifying Groups:

- a) The Respondent agrees with the finding.
- b) The District has been unable to fill this position. The District has created a public notice that has been posted at the District Office and the District Website on June 29, 2026. On June 30, 2026,

the public notice was also posted at two public places in Hughson, CA. It was posted that Hughson is looking to fill the vacant taxpayer position. This will be available to apply until the position has been fulfilled.
